<b>Background:</b>	Anti-Goat IgG F(ab') <sub>2</sub> Fluorescein Antibody generated in rabbit is a proteolytic fragment of immunoglobulin G (IgG) obtained by limited digestion with the enzyme pepsin under controlled conditions of temperature, time and pH. F(ab') <sub>2</sub> molecules lack the Fc portion of IgG and therefore receptors that bind goat IgG F(c) will not bind goat IgG F(ab') <sub>2</sub> molecules.

Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Fluorescein, anti-Rabbit Serum, Goat IgG, Goat IgG F(ab') <sub>2</sub> and Goat Serum. No reaction was observed against Goat IgG F(c).

Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
