Background:	MOUSE IgM (alpha chain) (RABBIT) Antibody generated in rabbit detects specifically mouse IgM whole molecule. Immunoglobulin M is the largest antibody isotype and the first to be secreted against an initial exposure to antigen. IgM is predominantly produced in the spleen. Formed from covalently linking 5 immunoglobulins together, the approximate molecular weight of IgM is 900kDa and possesses 10 binding sites (though due to the size of most antigens, not all sites are capable of binding at once). Due to this large size, IgM is typically isolated to the serum. Anti-Mouse IgM antibody is ideal for investigators in Immunology, Microbiology, and Cell Biology.

Purity/Specificity:This product was prepared from monospecific antiserum by immunoaffinity chromatography
using Mouse IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any
unwanted reactivities. Assay by immunoelectrophoresis resulted in a single precipitin arc
against anti-Alkaline Phosphatase (calf intestine), anti-Rabbit Serum, Mouse IgM, and Mouse
Serum. No reaction was observed against other mouse heavy or light chain proteins.



ELISA Results of Rabbit Anti-Mouse IgM Antibody Alkaline Phosphatase Conjugate tested against purified Mouse IgM Alk Phos. Each well was coated in duplicate with 1.0 μ g of Mouse IgM (p/n 010-0107). The working dilution is 1:6700. The starting dilution of antibody was 5 μ g/ml and the X-axis represents the Log10 of a 3-fold dilution. This titration is a 4parameter curve fit where the IC50 is defined as the titer of the antibody. Assay performed using ELISA Alkaline Phosphatase Substrate Buffer (p/n NPP-10) and NPP Working Buffer (p/n NPP-B500).
